All others: Approx. 1-1/4 mile course; Sportsman Extreme, GPS100, Crackerbox, Unblown Flat, K Racing Runabout Pro: either two (2) 4 lap heats/day or three (3) 3 lap qualifiers and one (1) 4 lap final/day. GN: two (2) 10 lap heats on Friday and 20 lap final on Saturday. Comp Jets, Classic Endurance: two (2) 4 laps heats/day. Mod VP: two (2) 4 or 5 lap heats/day (TBD based on attendance)
